- **Early Entry Discount Inspection Fee: \$100** - must be postmarked at least 6 weeks prior to inspection date
- **Regular Inspection Fee: \$125** – must be postmarked at least 5 weeks prior to inspection date
- **Late Entry Inspection Fee \$175** – must be postmarked at lease 3 weeks prior to the inspection date

## Inspection Guidelines (Open Inspections)

- 1. All horses must be registered or recorded with the IGGHR to participate in any IGGHR inspection.**
- 2. IGGHR registration paperwork must be submitted with the Inspection Entry Form if the horse is not already IGGHR registered.** If the horse is already IGGHR registered please submit a copy of the horse's registration certificate. Paperwork and payment is sent directly to: IGGHR, PO Box 90, Stamping Ground, KY 40379 (Do not send paperwork with a signature required.)
- 3.** Inspection entries, payment, and all registration paperwork (or copies of the IGGHR registration certificate, if your horse is already registered) must be postmarked at least 5 weeks prior to the inspection date to avoid late fees. Paperwork postmarked at least 6 weeks prior to the inspection date is eligible for a \$25 discount. Late entries are subject to late fees ranging from \$50-\$100 and may or may not be accepted at the discretion of the IGGHR and the inspection organizer. It is highly recommended to submit your inspection entries and paperwork postmarked at least 5 weeks prior to the inspection date.
- 4.** The inspection start time and sign-in time can vary based on the number of horses. Please contact the INSPECTION HOST to verify the start time and the sign-in time. All horses must be signed in prior to being inspected.
- 5.** The Champion and Reserve Champion Georgian Grande will be awarded. Georgian Grande horse scoring 73% or higher will earn Bronze Star Book status.
- 6.** Horses will be presented using the triangle, which is appx. 80 x 100 x 80 feet. At the inspector's discretion owners may have the option of letting their horse be shown at liberty also, if the host facility offers a safe area to do so. The safety of the horses and handlers is paramount.
- 7.** Unruly, unsafe, or unsound horses may be excused at the discretion of the inspector. Owners/ handlers may also withdraw at any time if they feel unsafe with their horse's behavior or for any reason.
- 8.** Horses (including foals) need at least enough basic handling to be able to stand for the conformation judging portion of the inspection, and to be able to walk and trot the triangle safely alongside the handler.
- 9.** Braiding of the mane is optional but recommended. Leg 'feather' may be trimmed or not, this is entirely optional. Decoration of the mane (for example, with beads, flowers, or ribbons) is not allowed. Glittery or paint on designs on the body of the horse are not allowed. Hoof polish may be used but must be clear or black.
- 10.** Bridles are required for horses two years old and older. The bridle should consist of a USEF dressage legal snaffle bit with a headstall and throatlatch. Nosebands are optional. Foals and horses younger than two years old are to be shown in a halter. The halter may include a browband.
- 11.** Boots, bandages, or wraps of any kind may not be used during inspection.
- 12.** The handler and/or their assistant may each carry one humane whip. No whip snapping, and no additional devices (such as bags) are allowed.
- 13.** Conservative attire is recommended. Polo shirts and beige, white, or khaki pants are common.

- 14.** Contact the inspection host / organizer directly with any questions about stabling, facility guidelines, availability of handlers, etc. Inspection host contact information is listed on the Inspection Form. Any expenses relating to stabling, handlers, braiders, etc., will be payable directly to the inspection host or to the handler, braider, etc. directly.
- 15.** Violations and enforcement of guidelines 9-13 is ultimately at the discretion of the inspector. The primary goal is to have inspections which are fair and safe and showcase the breed with dignity.
- 16.** The IGGHR reserves the right to refuse service to anyone.
